John B. Sullivan: Wake up New Hampshire before it's too late

I AM WRITING to address the bill H.R. 1 — the so-called "For the People Act" — that is being debated in the U.S. Senate. As citizens, we are all busy, our lives have been compromised by the pandemic and our lifestyles changed. Amid this, I don't think the people of our great state know enough about this bill that is being deliberated.

This bill aims to strip away New Hampshire's ability to decide for itself what our election policies and voting practices will be. It transfers to federal authorities the right to dictate who votes in our state and how we conduct elections.

If this bill were to pass the U.S. Senate — it already passed the U.S. House with Reps. Chris Pappas and Ann Kuster both in favor — New Hampshire would give up the congressional redistricting control of our state to Washington bureaucrats. I don't want Nancy Pelosi, Kevin McCarthy or anyone in Washington telling us, as citizens of New Hampshire, what to do. I am asking you to call and to write to your senators.
