I had the honor of hosting the Executive Council Breakfast meeting on Wednesday June 1, 2022. I selected the **New Hampshire Department of Justice - Office of the Attorney General** as the host agency.

At the beginning of the year I became aware of a discordance in the decline of elder abuse cases opened and the increase in calls to the Bureau of Elderly Adult Services (BEAS) - Adult Protective Services (APS) during the COVID pandemic. I reached out to the Attorney General's Elder Abuse and Financial Exploitation Unit to discuss the alarming increase in elder financial exploitation - exacerbated by the isolation during COVID.

Bryan Townsend, Senior Assistant Attorney General and Attorney Sunny Mulligan-Shea, Victim Witness Advocate for the Elder Abuse and Financial Exploitation Unit, discussed the unit's role in investigating and prosecuting financial elder abuse crimes statewide and the need to focus on New Hampshire's forecasted demographic shift. Listed below are some of the critical issues affecting our vulnerable seniors and the state.

- Nationwide 1 in 10 adults over the age of 65 are victims of elder abuse each year.
- Approximately 1 in 14 cases of elder abuse is reported in NH, with only 1 in 24 cases reported nationally.
- Elder abuse crimes include physical, psychological, sexual, financial exploitation, neglect and abandonment.
- By 2035 New Hampshire's senior citizen population will reach 479,000 a 7% increase from 2020.
- With increased life spans, the risk of cognitive impairment and physical decline (hearing, sight, mobility etc.) increases significantly which will **increase the risk of elder victimization.**
- Referrals to the Elder Abuse and Financial Exploitation Unit are increasing.

Just recently the Senior Assistant Attorney General and prosecutor for the Unit, were successful in sentencing a caregiver who was employed at a Londonderry long-term care facility and as an in-home caregiver in District Three, to a sentence of 7-20 years in the New Hampshire State prison, on charges of felony and misdemeanor counts of identity fraud, forgery, theft, and credit card fraud.

In 2019, while working as a caregiver in the dementia unit, the caregiver financially exploited four elderly residents, ages 87-99. After being fired from the facility, the caregiver worked as an in-home caregiver in Pelham and Salem – where once again – financially exploited two 87-year-old clients. Over the span of six months the caregiver committed 14 crimes against our most vulnerable residents.

#### KEEPING OUR CHILDREN SAFE - "WE ARE GOING TO FOCUS ON EVERY SCHOOL"

I asked Department of Education Commissioner Frank Edelblut for an update on the Public School Infrastructure Fund, which was established in 2017 to disburse \$30 million to New Hampshire's public and charter schools, to improve safety and address life and safety issues at New Hampshire schools. I also asked how many schools have accessed funding through the Public School Infrastructure program. The program has been successful - with \$3.3

million remaining in the fund- while funding 100% of New Hampshire Schools safety needs, according to Commissioner Edelblut.

Commissioner of Public Safety, Robert Quinn stressed that Public Safety will "focus on every single school in the state" - working with preparation and recommendations of the School Safety Task Force. He stressed that "plans are only as good as those who are familiar with them". Commissioner Quinn is working with State Police Colonel Nate Noyes to inform Troop Commanders across the state to "ensure they are familiar with these plans". Colonel Noyes will be working with Police Chiefs throughout the state, County Sheriffs "to ensure they are familiar with the plans". Additionally, response plans, communications plans etc. are being evaluated. Commissioner Quinn stressed that there is no higher priority than working on identifying/responding to safety gaps/vulnerabilities at our schools. Since the June 1st meeting, Governor Sununu and the Department of Education were successful in getting support from the Joint Legislative Fiscal Committee to allocate another \$10.2 million in American Rescue Plan Act State Fiscal Recovery Funds to the Public School Infrastructure Fund. Funds will be available for both public and private schools. The application for these grant dollars is pending. When the issue came to my attention several months ago, I requested Commissioner Mollica to explain the reason for closure and reconsideration.** Unfortunately, part time staffing shortages mandated that the staff at this seasonal store relocate to the year round store in Seabrook.

#### PEASE DEVELOPMENT AUTHORITY

<u>#66</u> Authorized the Division of Ports and Harbors to enter into a License and Operating Agreement with Granite State Minerals, Inc., Lowell, MA, for the purposes of outlining terms and conditions to allow GSM to install a mooring bollard on Division property at **315 Market St., Portsmouth, NH.** Effective upon G&C approval for the period of September 1, 2022 through August 31, 2040.

# GOVERNOR'S OFFICE FOR EMERGENCY RELIEF AND RECOVERY

#66A Authorized to finalize the grant agreement using the signed terms and conditions as detailed in letter dated May 25, 2022, in the amount totaling \$787,132 from the approved accept and expend of \$12,000,000 in American Rescue Plan Act State Fiscal Recovery Funds, previously approved on October 22, 2021, to grant funds for the safety and emergency equipment program for town and municipalities, which will be allowed for reimbursement of such investments incurred by December 31, 2022, that are allowable expenses under ARPA SFRF.
