

# *GRANITE STATE TAXPAYERS*

## **2024 NH HOUSE SCORECARD**

*Granite State Taxpayers (GST)* has reviewed the voting records of New Hampshire Legislators in the 2023-2024 session to show whether they supported issues and programs beneficial to the interests of taxpayers.

The *GST* scorecard for the 2023-2024 House considered forty seven roll-call votes taken over the course of the session. Besides taxes, bills were included on spending, business regulation, voting integrity, energy costs and other issues of interest to taxpayers. The bills and preferred votes were selected by the *GST* Board.

The scorecard lists each representative's score as a percentage of *GST* preferred votes, with half-credit given for missed votes. We do not list representatives who did not serve full two-year terms, or those who did not participate in at least fifteen of these votes.

The scorecard data shows that over the past four years, the voting of Republicans has become more supportive of taxpayers interests, and Democrats less so.

In the 2019-2020 House, 233 Democrats had an average score of 19%

In 2023-2024, 190 Democrats had an average score of 8%.

In the 2019-2020 House, 162 Republicans had an average score of 88%.

In 2023-2024, 199 Republicans had an average score of 95.

In four years, scores of Democrats decreased 11% and Republican increased 7%.
